Sokol and seconded by William H .Nicholson to hire Logan Koller as a part time probationary police officer for Cumberland Township at \$ 15.72 an hour after a year probationary period he will receive the rate of the regular part time police to agree with the Union Contract. Motion carried unanimously.

Motion was made by Samuel H . Hastings and seconded by William H .Nicholson to approve a lot split between Onderko/Onderko. Motion carried unanimously.
